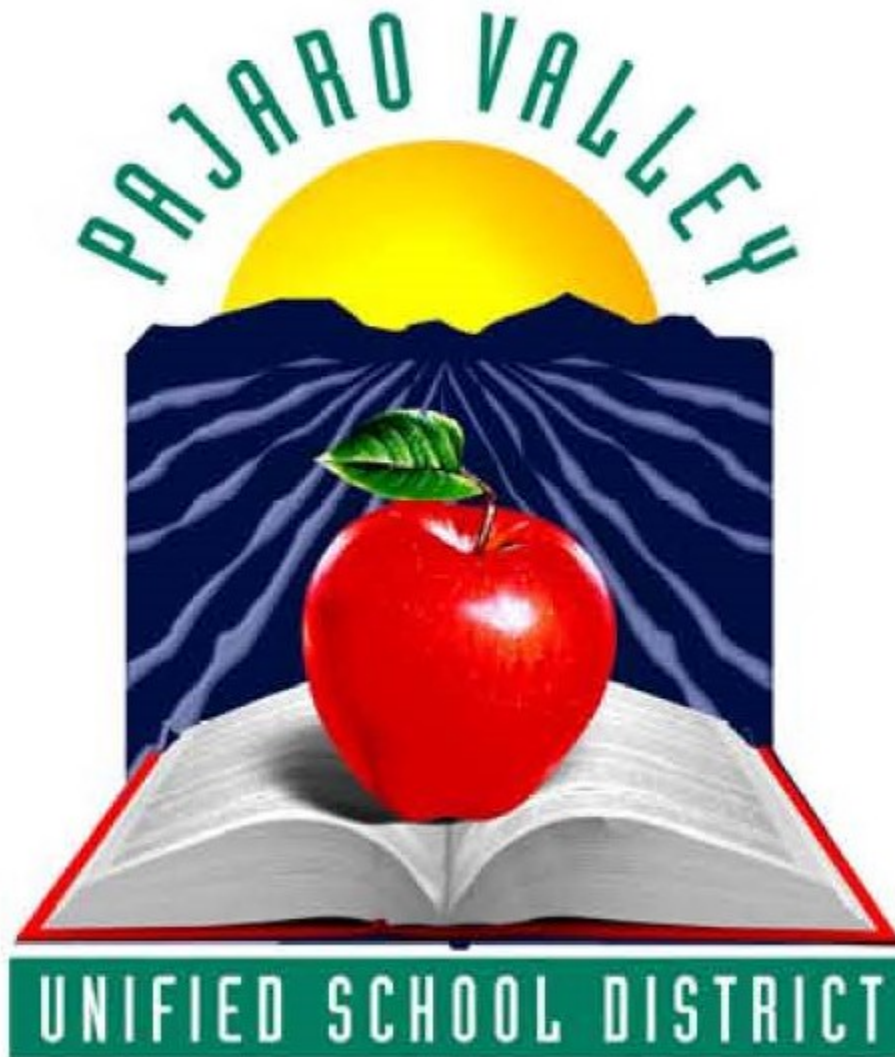

Purpose of the Comprehensive School Safety Plan (CSSP)

Sections 32280-32288 of the California Education Code outline the requirements of all schools operating any kindergarten and any grades 1 to 12, inclusive, to write and develop a Comprehensive School Safety Plan relevant to the needs and resources of that particular school.

It is the intent of the Legislature in enacting the provisions to support California public schools as they develop their mandated Comprehensive School Safety Plans that are the result of a systematic planning process, that include strategies aimed at the prevention of, and education about, potential incidents involving crime and violence on school campuses. Comprehensive School Safety Plans are required under SB 719 & AB 115 and must contain the following elements:

- Assessment of school crime committed on school campuses and at school-related functions
- Child abuse reporting procedures
- Disaster procedures
- Suspension and expulsion policies
- Procedures to notify teachers of dangerous pupils
- Discrimination and harassment policies
- School wide dress code policies
- Procedures for safe ingress and egress
- Policies enacted to maintain a safe and orderly environment
- Rules and procedures on school discipline
- Hate crime reporting procedures

The Comprehensive School Safety Plan will be reviewed and updated by March 1st every year. In July of every year, the school will report on the status of its school safety plan including a description of its key elements in the annual School Accountability Report Card (SARC).

School Safety Strategies and Programs

Pajaro Valley High School is committed to school safety for all students, staff, and visitors. Many strategies and programs provide and maintain a high level of school safety.

School Vision/Mission Statement

Pajaro Valley High School's vision and Mission is to:

Educate advocacy, awareness and responsibility in partnership with our community.

Providing a safe learning environment is a priority for staff, parents, students, and school community members. Pajaro Valley High School prepares students to be self-disciplined and responsible citizens who can meet the challenge of living in an ethnically and socio-economically diverse community. Pajaro Valley High School promotes caring and nurturing relationships and work cooperatively with parents, students, law enforcement representatives, and other community agencies. Pajaro Valley High School stresses prevention of violence on campus and prepares students to handle conflict, anger, and other threats to safety.

Programs are implemented to prevent drug, alcohol, and tobacco use. The Pajaro Valley High School discipline policy provides students with behavior guidelines that are aligned to the California Education Code and district policies. School-wide rules, classroom rules, the dress code, and consequences for rule infractions provide students with clear expectations for behavior. The focus is to reduce barriers to learning as well as to build protective factors leading to student success, both academically and socially.

Intervention and prevention programs focus on positive youth development. Pajaro Valley High School implements programs to create a positive school climate and promote social-emotional learning using research-based strategies. Pajaro Valley High School implements multi-tiered systems of support/response to intervention for students that promote high expectations, maintain student engagement in school, and provide systems for student success.

Strategies and programs unique to Pajaro Valley High School that provide a safe learning environment for all students, including specifically for LGBTQ students.

Pajaro Valley High School: Bullying Prevention and Protocols

AB 537:

AB 537, the California Student Safety and Violence Prevention Act of 2000, changed California's Education Code by adding actual or perceived sexual orientation and gender identity to the existing nondiscrimination policy. State law says that "'gender' means sex, and includes a person's gender identity and gender related appearance and behavior whether or not stereotypically associated with the person's assigned sex at birth." The nondiscrimination policy also prohibits harassment and discrimination on the basis of sex, ethnic group identification, race, ancestry, national origin, religion, color, or mental or physical disability.

What is bullying:

- Is aggressive behavior that intends to cause harm or distress
- Usually repeated over time
- Occurs in a relationship where there is an imbalance of power or strength

Bullies need an audience:

- Bullying happens when others will see it and know about it
- The point of Bullying is to get more popular while making some else less popular
- All of us have seen it happen either as a victim, as a witness, or maybe even as a bully ourselves
- We can do more than watch and go along
- There are many more witnesses than bullies and victims.
- There is strength in numbers. We can use our own social power to help the victim

- If we stay quiet, the bully thinks we approve of the mean treatment of the victim

Different Types of Bullying:

- Verbal (Using words to harm)
- Physical (Using violence to harm)
- Cyber (Using electronic communications to harm)
- Relational (Using relationships/friendships to harm)

What can we do to:

- Offer kind words to the student who was targeted
- Seek adult help
- Do not participate in the bullying behavior in person or online
- Do not become involved in excluding friends, spreading rumors or gossip in person or online
- If it possible tell the student who is bullying that what s(he) is doing is wrong
- Do not become involved in physical or verbal arguments with a student who displays bullying behavior

How to file a complaint:

If a student is being bullied or harassed they should begin by telling the person who is harassing them to stop. At this point, the student has the option to wait and see if it happens again or to report the situation.

If the bullying continues they can:

- Inform a teacher,
- Tell their school counselor,
- Report the incident to another adult on campus,
- Tell their parent/guardian.

If the harassment continues from the same individual, it is very important that the student informs a trusted adult that the attempts to make the behavior stop have failed and that stronger more serious action will be required.

If a student receives threatening communication (including, but not limited to, in person, via text and/or social media) student needs to tell their parent/guardian or a trusted adult immediately. Students should save all communications (including, but not limited to text, voicemail, social media) and share it with an adult. If a student sees someone else at school being bullied, they should find assistance and inform an adult about the concerns.

Pajaro Valley High School Has many unique programs that are offered to help nurture a safe and positive school experience.

PBIS: Positive Behavior Interventions and Supports. PBIS is a system adopted by Pajaro Valley High School to help foster a positive school climate and experiences.

What is PBIS: Although initially established to disseminate evidence-based behavior interventions for students with Behavior Disorder I, the National TA Center on PBIS shifted focus to the school-wide behavior support of all students, and an emphasis on implementation practices and systems. As a result, PBIS is defined as a framework for enhancing the adoption and implementation of a continuum of evidence-based interventions to achieve academically and behaviorally important outcomes for all students.

GSA/QSA: Gay straight alliance/Queer straight alliance.

What is GSA/QSA: These clubs help promote a safe and accepting environment for all members of our campus regardless of race, religion or sexual orientation. The motto of these two clubs is "The only difference that matters is the one we are making".

ASB/Student Leadership: Pajaro Valley High School offers students the opportunity to become leaders on campus and help promote and provide opportunities for the student body to enjoy. This program teaches a sense of leadership, responsibility and the promotion of the overall climate and culture of the campus.

Student Success Project is a pilot program on campus. Their role is to help assist in counseling and mentoring of at-risk youth. Liliana Gonzales-Aguilar and Jose Rocha are our two representatives.

Child Abuse Reporting Procedures

(EC 35294.2 [a] [2]; PC 11166)

All school staff members actively monitor the safety and welfare of all students. Staff members understand their responsibility as child-care custodians and will immediately report all cases of known and suspected child abuse pursuant to Penal Code Section 11166. District employees who are mandated reporters, as defined by law and administrative regulation, are obligated to report all known or suspected incidents of child abuse and neglect.

Penal Code 11166. (a) Except as provided in subdivision (d), and in Section 11166.05, a mandated reporter shall make a report to an agency specified in Section 11165.9 whenever the mandated reporter, in his or her professional capacity or within the scope of his or her employment, has knowledge of or observes a child whom the mandated reporter knows or reasonably suspects has been the victim of child abuse or neglect. The mandated reporter shall make an initial report by telephone to the agency immediately or as soon as is practicably possible, and shall prepare and send, fax, or electronically transmit a written follow up report within 36 hours of receiving the information concerning the incident. The mandated reporter may include with the report any non-privileged documentary evidence the mandated reporter possesses relating to the incident.

Plans are also completed to assure ongoing monitoring of the student. School staff work closely with police and Child Protective Services with follow up actions as needed. Considerable effort is made to maintain the confidentiality of the student and employee in all cases of child abuse reporting. Copies of all written reports are maintained in a confidential file in the principal's office. Board Policy 5141.4 addresses Child Abuse Prevention and Reporting and is included in the Appendix of the Comprehensive School Safety Plan.

All staff complete a yearly training in child abuse prevention and reporting.

Procedures for Emergency Use by Public Agency – BP 3516

As documented in Board Policy 3516, public agencies, including the American Red Cross, have permission to use school buildings, grounds, and equipment for mass care and welfare shelters during disasters or other emergencies affecting the public health and welfare. The Board will cooperate with such agencies in furnishing and maintaining whatever services they deem necessary to meet the community's needs. Board Policy 3516 is included in the Appendix.

Suspension/Expulsion Policies – BP 5144.1

As documented in Board Policy 5144.1, the school desires to provide students access to educational opportunities in an orderly school environment that protects their safety and security, ensures their welfare and well-being, and promotes their learning and development. Rules and regulations set the standards of behavior expected of students and the disciplinary processes and procedures for addressing violations of those standards, including suspension and/or expulsion. Board Policy 5144.1 is included in the Appendix.

Procedures to Notify Teachers of Dangerous Pupils – BP 5119, BP 5131.4 & BP 5131.7

As documented in Board Policy 5119, BP 5131.4 & BP 5131.7, the Superintendent or designee shall ensure that employees are informed, in accordance with law, regarding crimes and offenses by students who may pose a danger in the classroom. Board Policy 5119, BP 5131.4 & BP 5131.7 is included in the Appendix.

All teachers are informed in writing (and verbally if possible) of any students who may pose a danger in the classroom. When a student commits an unsafe act that results in suspension, teachers receive a notification before the student returns to school. The notification can be in a verbal or email form.

Nondiscrimination/Harassment Policy – BP 5145.3

As documented in Board Policy 5145.3, the Board of Education desires to provide a safe school environment that allows all students equal access and opportunities in the district's academic and other educational support programs, services, and activities. The Board prohibits, at any district school or school activity, unlawful discrimination, including discriminatory harassment, intimidation, and/or bullying of any student, based on actual or perceived characteristics of race or ethnicity, color, nationality, national origin, ethnic group identification, age, religion, physical or mental disability, sex, sexual orientation, gender, gender identity, gender expression, or any other characteristic identified in Education Code 200 or 220, Penal Code 422.55, or Government Code 11135, or based on association with a person or group with one or more of these actual or perceived characteristics. Board Policy 5145.3 is included in the Appendix.

Strategies and programs unique to Pajaro Valley High School that provide a safe school environment for all students, including specifically for LGBTQ students.

Non-Discrimination Policy

The Pajaro Valley Unified School District (Local Educational Agency) has adopted a policy that prohibits discrimination, harassment, intimidation, and bullying based on actual or perceived ancestry, age, color, disability, gender, gender identity, gender expression, nationality, race or ethnicity, religion, sex, sexual orientation, or association with a person or a group with one or more of these actual or perceived characteristics. The policy includes the following: a) A statement that it applies to all acts related to school activity or school attendance within a school under the jurisdiction of the superintendent of the school district. b) Requirement that school personnel takes immediate steps to intervene when safe to do so when he or she witnesses an act of discrimination, harassment, intimidation, or bullying.

Pajaro Valley High School has implemented Positive Behavior Interventions and Supports (PBIS) that is based on coherent and consistent school-wide behavioral expectations that teach and reinforce positive behaviors. The school-wide behavioral expectations are established in Grizzly P.R.I.D.E. Grizzlies use P.R.I.D.E. to live and act in such a way that Pajaro Valley High School becomes a community of Grizzlies who utilizes Personal Responsibility, Respect, Integrity, Diversity, and Excellence. P.R.I.D.E. will be applied to all settings on campus (classrooms, hallways, quad, cafeteria, restrooms, locker rooms, library, buses, parking lots, and the office) and at school-related events. Grizzlies are awarded points and earn rewards for exhibiting P.R.I.D.E. by Grizzly staff. We are using the 5 Star Students System to track a student's points for displaying positive behaviors. Also, students can earn points by participating in extra and co-curricular activities and by attending certain school events. Students will need their Student Identification Cards or Student I.D. used to award points for positive behavior. Students are able to redeem their points for rewards with the PV Nation 5-Star Point System

DISCIPLINARY PROCEDURES

Pajaro Valley High School has developed a code of conduct and disciplinary procedures to help students understand what is expected of them and the consequences that follow violations of the rules. Pajaro Valley High School developed the following behavioral intervention Flowchart to fairly and equitably address minor and major offenses. [CA Ed. Code 32051] A standard procedure for dealing with violations of the school's Code of Conduct has been developed to ensure fairness to all students. For each offense, there is a prescribed consequence ranging from a conference with the student to suspension for major offenses. Examples of both minor and major offenses can be found in the Pajaro Valley High School Student Discipline Regulations. No person will be allowed to interfere with another student's right to learn or to disrupt the normal educational process.

DESCRIPTION OF CONSEQUENCES AND INTERVENTIONS

PARENT/GUARDIAN CONFERENCING, COUNSELING, AND/OR MEDIATION

Students will be counseled after the first offense depending on the nature of the offense and warned of the consequences if the offense is repeated. Counseling services may be provided by the school administration, PVHS Counselors, or by Pajaro Valley Prevention and Student Assistance. Parent/guardian notification or conference and/or a behavior contract may be necessary.

PRIDE Intervention

Students will be given a selected intervention program in replacement of disciplinary disposition. These programs will

consist of a variety of programs such as CRT (conflict resolution team), Restorative practices, behavior agreements/contracts, SSP (student success project) mentoring, PVPSA counseling, and At-Risk Student Intervention Meetings, with more coming.

SATURDAY ACADEMY (Saturday School)

It is possible for students to make up all or some of the accumulated absences by attending Saturday Academy, which is offered in increments of four hours. Saturday Academy is assigned for students who have been truant or who are excessively tardy. It is also assigned when lesser consequences have failed to bring about needed behavior changes. Saturday Academy is held from 8:30 am to 12:30 pm on specifically assigned Saturdays, and students are required to bring coursework.

Attendance is mandatory and transportation to and from Saturday School is the responsibility of the student or parent/guardian. Failure to attend or to behave appropriately while at Saturday Academy will result in additional disciplinary consequences, including but not limited to one day out of school suspension, the risk of not being able to participate in school activities, etc.

Any student arriving after 8:35 am at Saturday Academy will be counted as a no-show and will not be allowed to attend. Any disruption/defiance at Saturday Academy will result in the student being sent home immediately by the instructor in charge. The student will receive further disciplinary action and a possible suspension from school.

STUDENT AGREEMENTS FOR SATURDAY ACADEMY:

- Students agree to be on the Cafeteria stairs at PVHS by 8:30 am and dressed appropriately
- Students agree to bring books/coursework for study
- Students who are assigned detention and or Saturday Academy agree to be responsible for remembering the scheduled days.
- If unable to attend, the parent/guardian of the student agrees to notify the Assistant Principal. Please coordinate changes in advance with an Assistant Principal.

If students become ill on the day of an assigned Saturday Academy, the parent/guardian agrees to call the PVHS Main Office at 728-8102 by 9:30 am the following Monday.

EVENT EXCLUSION

At the discretion of the administration, students may be excluded from a future school event(s) such as Winter Ball, Prom, Graduation Ceremony, or an athletic event, particularly if the infraction occurred at a similar event. In order to attend an after-school event, the student must have attended classes during the school day. Factors that will be taken into consideration are attendance, discipline, parking, and grades.

CLASS SUSPENSION

A teacher may suspend any pupil from class the day of the action and one day following for disruptive behavior in the classroom and /or defiance of the teacher. Teachers will send student(s) to an assistant principal with a PVHS Student Referral Form.

SUSPENSION

While a student is under suspension, the student may not be on campus or at any school-sponsored event, home or away, for any reason without specific administrative permission. Students who are suspended who are also athletes may not participate in practice or games during the days of suspension. When other consequences have failed to bring about desired behavior or for certain serious offenses, a student will be suspended from school. In compliance with the California Education Code, students who accrue 20 days of at-home suspension must be recommended to the School Board for possible expulsion from the School District.

WORK MISSED DUE TO SUSPENSION: The teacher of any class from which a student is suspended may require the suspended student to complete assignments and tests missed during the suspension (California Education Code 48913). We recommend that students contact teachers directly through email to request assignments.

HOMEWORK WHILE SUSPENDED: On notification from the administration, homework may be requested by school counselors from all teachers when a student is suspended for at least three days. Teachers are required to provide access to all academic information missed during a suspension; however, the responsibility is on the student to complete the work in a timely fashion. Students are expected to email teachers or check teacher websites to see what they are missing. It is strongly recommended that students email their teachers directly so that they have the most accurate and current information regarding their academics.

EXPULSION

Expulsion is considered in specific serious offenses as defined in California Education Codes 48900 and 48915. Expulsion means the removal of a student from the school of attendance and from any district school for no more than the semester in which the infraction occurs and the semester following.

Upon successfully completing the terms of expulsion, as set forth by the School Board, the student may return to the district with the approval of the School Board.

The decision of whether or not to recommend a student for expulsion is the responsibility of the Principal. As in all cases, this decision will be based on a careful review of the circumstances surrounding the individual case and situation. The Principal will follow the procedures as prescribed in the California Education Code. A meeting will be held between the student, parent/guardian, and the Principal (or the Principal's designee) to discuss the issues and the procedures. The expulsion process has specific timelines in order to protect the due process rights of the student.

CAUSES FOR SUSPENSION AND EXPULSION/APPLICABILITY OF SCHOOL RULES

A student may be suspended or recommended for expulsion if the offense occurs while on school grounds, going to or coming from school or at a school-related activity off-campus. Students may also be suspended or expelled if the offense occurs at a school-sponsored activity off campus or going to or coming from any school-sponsored activity.

CAUSES FOR IMMEDIATE EXPULSION

1. Possessing, selling, or otherwise furnishing a firearm [Ed. Code 48915 (c) (1)].
2. Brandishing a knife at another person [Ed. Code 48915©(2)]
3. Unlawfully selling a controlled substance listed in Chapter 2 (commencing with Section 11053) of Division 10 of the Health and Safety Code [Ed. Code 48915©(3)], CA Health and Safety Code Section 11351-11360].
4. Committing or attempting to commit a sexual assault as defined in subdivision (n) of Section 48900 [Ed. Code 48915©(4)].
5. Possession of an explosive [Ed. Code 48915©(4)].

Anti-Bullying Discrimination Policy

Bullying and harassment are not tolerated at Pajaro Valley High School. It is expected that teachers, staff, and students will immediately report any type of bullying or harassment for administrative action. California law and PVUSD Board Policy protecting students and staff:

California laws (California Safe Schools):

California law explicitly provides that public schools and non-religious private schools that receive state funding, have a legal duty to protect students from discrimination and harassment on the basis of actual and perceived gender identity. California Education Code §§ 200-220.

The Department of Education regulations implementing this law state that: [N]o person...shall be subjected to discrimination, or any form of illegal bias, including harassment. No person shall be excluded from participation in or denied the benefits of any [school] program or activity on the basis of . . . gender . . . Title 5, California Code of Regulations, § 4900(a).

The law defines "gender" very broadly: "Gender" means sex, and includes a person's gender identity and gender-related appearance and behavior whether or not stereotypically associated with the person's assigned sex at birth. Penal Code § 422.56 (effective Jan. 1, 2005, as amended by S.B. 1234 (2004)). [1]

AB 537 is the California Student Safety and Violence Prevention Act of 2000 and protects students and school employees against discrimination and harassment at all California Public Schools. This includes the actual or perceived sexual orientation and gender identity.

Pajaro Valley High School Has many unique programs that are offered to help nurture a safe and positive school experience.

PBIS: Positive Behavior Interventions and Supports. PBIS is a system adopted by Pajaro Valley High School to help foster a positive school climate and experiences.

What is PBIS: Although initially established to disseminate evidence-based behavior interventions for students with Behavior Disorder I, the National TA Center on PBIS shifted focus to the school-wide behavior support of all students, and an emphasis on implementation practices and systems. As a result, PBIS is defined as a framework for enhancing the adoption and implementation of a continuum of evidence-based interventions to achieve academically and behaviorally important outcomes for all students.

GSA/QSA: Gay straight alliance/Queer straight alliance.

What is GSA/QSA: These clubs help promote a safe and accepting environment for all members of our campus regardless of race, religion, or sexual orientation. The motto of these two clubs is "The only difference that matters is the one we are making".

ASB/Student Leadership: Pajaro Valley High School offers students the opportunity to become leaders on campus and helps promote and provide opportunities for the student body to enjoy. This program teaches a sense of leadership, responsibility, and the promotion of the overall climate and culture of the campus.

Student Success Project is a pilot program on campus. Their role is to help assist in counseling and mentoring at-risk youth. Liliana Gonzales-Aguilar and Jose Rocha are our two representatives.

Dress Code – BP 5132

As documented in Board Policy 5132, the Board of Education believes that appropriate dress and grooming contribute to a productive learning environment. The Board expects students to give proper attention to personal cleanliness and to wear clothes that are suitable for the school activities in which they participate. Students' clothing must not present a health or safety hazard or a distraction which would interfere with the educational process. Students are prohibited from wearing gang-related apparel when there is evidence of a gang presence that disrupts or threatens to disrupt the school's activities. Board Policy 5132 is included in the Appendix.

No clothing, attire, jewelry, or accessories will be allowed that detracts from a safe and productive learning environment.

The Pajaro Valley High School dress code was developed by students, parents/guardians, teachers, and administrators for the express purpose of helping to promote and support a safe, peaceful, positive learning environment free from distractions for all students. Students are expected to dress appropriately for school. Standards with regard to cleanliness, modesty,

safety, and appropriateness of dress will be maintained. Students who are inappropriately dressed will not be allowed to attend classes until the situation is remedied. Continual or flagrant violations of the school Dress Code will result in after school detention, in-school suspension, or other disciplinary consequences. If students have any questions regarding the Dress Code, please contact an assistant principal or the PVUSD Student Services Office for further questions or clarifications.

**THE FOLLOWING ITEMS/ATTIRE
ARE EXPRESSLY PROHIBITED ON CAMPUS:**

Unauthorized Groups:

Unauthorized group style clothing may vary and change from year to year but specifically attire or articles of clothing commonly held to be related to a gang or gang activity are not permitted. No clothing or apparel which may intimidate others or provoke others to acts of violence will be allowed on campus or at any school related activity (District Policy 4508.31).

Dangerous Objects

Articles of clothing, jewelry, or accessories which could pose a threat to the physical well-being and safety of students or others or disrupt the learning environment are not to be worn on campus.

Inappropriate Attire

Any item of clothing or jewelry which depicts or suggests any illegal activity, is explicitly sexual, or portrays obscene gestures, pictures, logos, insignias or wording, or the use, abuse or promotion of drugs or alcohol in any form is not allowed on campus or at any school related activities. Students wearing clothing that is deemed excessively revealing will be asked to either put something on over the item or will be sent home to change into more appropriate clothing for attending Pajaro Valley High School.

Rules and Procedures for School Discipline – BP 5144

As documented in Board Policy 5144, the Board of Education is committed to providing a safe, supportive, and positive school environment which is conducive to student learning and to preparing students for responsible citizenship by fostering self-discipline and personal responsibility. The Board believes that high expectations for student behavior, use of effective school and classroom management strategies, provision of appropriate intervention, provision of appropriate intervention and support, and parent involvement can minimize the need for disciplinary measures that exclude students from instruction as a means for correcting student misbehavior.

The primary responsibility for discipline in the classroom rests with the teacher. Teachers will inform students of their classroom rules and what procedures will be followed for any violation of these rules. Minor misconducts shall be dealt with by the teacher while major misconducts will be dealt with by administration. While discipline should be a form of "progressive discipline", certain infractions can and will result in more serious consequences.

Below is a list of more serious discipline issues and their potential consequences:

These 5 offenses will result in a mandatory expulsion:

- Possessing, selling or otherwise furnishing a firearm
- Brandishing a knife at another person
- Selling any controlled substance
- Committing or attempting to commit sexual assault or sexual battery.
- Possession of an explosive

These offenses can/will result in serious consequences beyond teacher progressive discipline policies.

- Committing or threatening to commit assault or battery upon any school employee
- Making terroristic threats against school personnel or school property
- Causing serious injury to another person except in self defense
- Possession of or otherwise furnishing any knife, explosive, or other dangerous object
- Possession of an imitation firearm
- Committing or attempting to commit robbery
- Causing, attempting to cause, threatening to cause, or participating in any act of hate violence
- Possession for sale or providing any controlled substance including marijuana, and alcoholic beverages or intoxicants of any kind
- Harassing, threatening, intimidating, or retaliating against a pupil who is a complainant or witness in a school disciplinary proceeding
- Fighting (physical or verbal)
- Defiance of school authority
- Offer, arrange or negotiate to sell any substance represented as a controlled substance, alcohol, or intoxicant
- Possessing, using, or being under the influence of any controlled substance, alcoholic beverage or intoxicant of any kind
- Possession, offering, or selling any drug paraphernalia
- Harassment, threats or intimidation toward other students
- Sexual harassment
- Causing or attempting to cause damage to school or private property.
- Possession or use of tobacco or nicotine products

- Stealing, attempting to steal, or knowingly receiving stolen school or private property
- Disrupting school activities or otherwise willfully defying school personnel or school rules
- Profanity, obscene, or vulgar acts
- Creating a hostile or intimidating environment

Bullying Prevention – BP 5131.2

As documented in Board Policy 5131.2, the Board of Education is committed to creating a safe learning and working environment for all students and employees. The Board of Education recognizes the harmful effects of bullying on student learning and school attendance and desires to provide safe school environments that protect students from physical and emotional harm. District employees shall establish student safety as a high priority and shall not tolerate bullying of any student.

No student or groups of students shall, through physical, written, verbal, or other means, harass, sexually harass, threaten, intimidate, cyberbully, cause bodily injury to, or commit hate violence against any other student or school personnel. Board Policy 5131.2 is included in the Appendix.

Strategies and programs unique to Pajaro Valley High School that prevent bullying for all students, including specifically for LGBTQ students.

Pajaro Valley High School: Bullying Prevention and Protocols

AB 537:

AB 537, the California Student Safety and Violence Prevention Act of 2000, changed California's Education Code by adding actual or perceived sexual orientation and gender identity to the existing nondiscrimination policy. State law says that "gender" means sex, and includes a person's gender identity and gender related appearance and behavior whether or not stereotypically associated with the person's assigned sex at birth." The nondiscrimination policy also prohibits harassment and discrimination on the basis of sex, ethnic group identification, race, ancestry, national origin, religion, color, or mental or physical disability.

What is bullying:

- Is aggressive behavior that intends to cause harm or distress
- Usually repeated over time
- Occurs in a relationship where there is an imbalance of power or strength

Bullies need an audience:

- Bullying happens when others will see it and know about it
- The point of Bullying is to get more popular while making some else less popular
- All of us have seen it happen either as a victim, as a witness, or maybe even as a bully ourselves
- We can do more than watch and go along
- There are many more witnesses than bullies and victims.
- There is strength in numbers. We can use our own social power to help the victim
- If we stay quiet, the bully thinks we approve of the mean treatment of the victim

Different Types of Bullying:

- Verbal (Using words to harm)
- Physical (Using violence to harm)
- Cyber (Using electronic communications to harm)
- Relational (Using relationships/friendships to harm)

What can we do to:

- Offer kind words to the student who was targeted
- Seek adult help
- Do not participate in the bullying behavior in person or online
- Do not become involved in excluding friends, spreading rumors or gossip in person or online
- If it possible tell the student who is bullying that what s(he) is doing is wrong
- Do not become involved in physical or verbal arguments with a student who displays bullying behavior

How to file a complaint:

If a student is being bullied or harassed they should begin by telling the person who is harassing them to stop. At this point, the student has the option to wait and see if it happens again or to report the situation.

If the bullying continues they can:

- Inform a teacher,
- Tell their school counselor,
- Report the incident to another adult on campus,
- Tell their parent/guardian.

If the harassment continues from the same individual, it is very important that the student informs a trusted adult that the attempts to make the behavior stop have failed and that stronger more serious action will be required.

If a student receives threatening communication (including, but not limited to, in person, via text and/or social media) student needs to tell their parent/guardian or a trusted adult immediately. Students should save all communications (including, but not limited to text, voicemail, social media) and share it with an adult. If a student sees someone else at school being bullied, they should find assistance and inform an adult about the concerns.

STOPit is an app-based tool that our site uses that allows students or families to make an anonymous report to school administrators at any time - on or off-campus. Students can report through either an app downloaded to their device or through a web-browser on any computer. Students can report: bullying, cyber bullying, violence, threats, substance abuse, suicide ideation, asking for help for themselves or friends, or any unsafe situation. STOPit allows site administration to communicate in real-time with the person making the report through a texting feature. Students can upload photos, videos, and any other information that will allow site administrators to address issues as they arrive. STOPit is also monitored 24/7 by both District Administration and the STOPit organization to provide immediate support for emergency situations after-hours.

Positive School Climate – BP 5137

As documented in Board Policy 5137, the Board of Education desires to enhance student learning by providing an orderly, caring, and nurturing educational and social environment in which all students can feel safe and take pride in their school and their achievements. The school environment should be characterized by positive interpersonal relationships among students and between students and staff.

The district's curriculum shall include age-appropriate character education which includes, but is not limited to, the principles of equality, human dignity, mutual respect, fairness, honesty, and citizenship. The Superintendent or designee may develop other strategies to enhance students' feelings of connectedness with the schools, such as campus beautification projects, graffiti removal, development of extracurricular activities and after-school programs, pairing of adult mentors with individual students, recognition of student achievement, and encouragement of strong family and community involvement in the schools. Board Policy 5137 is included in the Appendix.

Pajaro Valley High School utilizes many clubs and organizations to help promote a positive and safe school climate. With over 20 clubs and organizations to choose from, students are given ample opportunity to find their place.

The primary focus will be on building students' capacity for academic success and positive social and emotional well-being.

Uniform Complaint Procedure – BP 1312.3

As documented in Board Policy 5137, the Board of Education recognizes that the district has the primary responsibility to ensure compliance with applicable state and federal laws and regulations governing educational programs. The Board encourages early resolution of complaints whenever possible. To resolve complaints which may require a more formal process, the Board adopts the uniform system of complaint processes specified in 5 CCR 4600-4670 and the accompanying administrative regulation. Board Policy 1312.3 is included in the Appendix.

Strategies and programs unique to Pajaro Valley High School that encourage early resolution of complaints for all students, including specifically for LGBTQ students.

Protocols to Address Mental Health Care of Pupils Who Have Witnessed a Violent Act

Pupils who have witnessed a violent act at school or at a school-sponsored activity, while going to or coming from school or a school sponsored activity, or during a lunch period on or off campus, will need attention to address their mental health. Witnessing violence and being a victim of violence at school have been found both positively and significantly associated with child psychological trauma symptoms and self-reported violent behavior, even after controlling for the effects of various demographic factors. Serious emotional and behavioral consequences can occur for students who are merely witnesses to violence (Flannery, D. J., Wester, K. L., & Singer, M. I., 2004).

Teachers and staff has direct access to our online mental health and wellness referral form online and on our website.

Our site utilizes a variety of tools to allow students to report incidents and ask for help. STOPit is an app and web-based reporting tool which allows students to anonymously report incidents in real time to site and district administration. This tool allows students to upload photos, images, screenshots, or videos. The interface includes a texting feature allowing administration to ask follow-up questions and ascertain more information in real time, including after-hours. STOPit also

has 24/7 monitoring and will contact law enforcement if immediate support is needed. This tool increases the ability for our site to get needed resources where needed in a timely manner.

Gaggle is another program which monitors students' use of district-assigned technology and alerts site and district administrators when certain keywords are used indicating a student may need help or is in crisis. Like STOPit, this tool allows for site administration and counselors to efficiently connect students and families to mental health resources.

We have a Site Wellness Team (SWT) to identify, assess, triage, provide resources, and make referrals for students experiencing mental health needs. The Site Wellness team meets weekly and is composed of site administration, health staff, teachers, and mental health staff (Social Emotional Counselor, Psychologist, Mental Health Clinician). Teachers are the first line of contact and refer students in need of support directly to the Site Wellness Team. The Social Emotional Counselor works with the SWT to coordinate needed services. The Social Emotional Counselor checks-in with students and families, assesses mental health needs, and makes appropriate referrals to site or community based mental health agencies.

When our site identifies a student as having needs that require services beyond our site resources, we refer to the District Wellness Team for further support. The District Wellness Team coordinates with district Mental Health Clinicians, Pajaro Valley Prevention and Student Assistance (PVPSA), County Children's Mental Health, and other community mental health agencies to coordinate services and provide support.

For students in crisis (non life-threatening emergencies and/or active suicide ideation), we coordinate with district Mental Health Clinicians and Pajaro Valley Prevention and Student Assistance (PVPSA) crisis counselors to provide immediate care. These Mental Health Clinicians and Crisis Counselors will immediately meet with the student/family, assess mental health needs, and provide immediate crisis care and appropriate referrals for follow-up care.

Procedures for Safe Ingress and Egress of Pupils, Parents, and School Employees to and from school

In an effort to assure the safety and welfare of students, parents, and visitors to Pajaro Valley High School, the following procedures should be followed when traveling to and from the school site:

- Daily Bus Drop-off & Pick-up at School:
- Students Walking to School:
- Students and Adults visiting the school site after hours or on weekends:

Daily Bus Procedures: Students are dropped off at a designated spot on the campus. Students disembark from the bus and move directly and safely onto campus. The pick up of students on the bus is done with the same procedure. Students are picked up in a designated spot, where they wait safely for the bus and load on the bus and exit the school grounds.

Students walking to school: Students who walk to school are required to stay on the clearly marked sidewalk on approach to the school. Once on school grounds, they are guided and instructed by campus security and brought safely onto school grounds.

Visitors on campus: Visitors on campus during school hours must park in designated visitor parking and report immediately to the main office to sign in. Visitors are not allowed on school campus after school hours unless prior authorization is given from a staff member. School gates are locked in the evening and no access to the campus is available..

The comprehensive safety plan(s) shall be reviewed and updated by March 1 of each year. (Education Code [32286](#))

The Board shall review the comprehensive safety plan(s) in order to ensure compliance with state law, Board policy, and administrative regulation and shall approve the plan(s) at a regularly scheduled meeting.

By October 15 of each year, the Superintendent or designee shall notify the California Department of Education of any schools that have not complied with the requirements of Education Code [32281](#). (Education Code [32288](#))

Tactical Response Plan

Notwithstanding the process described above, any portion of a comprehensive safety plan that includes tactical responses to criminal incidents that may result in death or serious bodily injury at the school site, including steps to be taken to safeguard students and staff, secure the affected school premises, and apprehend the criminal perpetrator(s), shall be developed by district administrators in accordance with Education Code [32281](#). In developing such strategies, district administrators shall consult with law enforcement officials and with a representative of an employee bargaining unit, if he/she chooses to participate.

When reviewing the tactical response plan, the Board may meet in closed session to confer with law enforcement officials, provided that any vote to approve the tactical response plan is announced in open session following the closed session. (Education Code [32281](#))

The needs assessment also should examine the extent to which those needs are

being met through existing services in the district and in the community, the costs of providing those services, and any gaps, delay, or duplication of services.

The Board will be informed of the services to be offered by the district, the resources that will be allocated to support collaboration, any use of school facilities for services, and any development or joint use of facilities with other jurisdictions.

Board Policy 5141.4 Child Abuse Prevention and Reporting

The Board of Education recognizes the district's responsibility to educate students about the dangers of child abuse so that they will acquire the skills and techniques needed to identify unsafe situations and to react appropriately and promptly.

The district's instructional program shall include age-appropriate and culturally sensitive child abuse prevention curriculum. This curriculum shall explain students' right to live free of abuse, inform them of available support resources, and teach them how to obtain help and disclose incidents of abuse. The curriculum also shall include training in self-protection techniques.

The Superintendent or designee shall seek to incorporate community resources into the district's child abuse prevention programs. To the extent feasible, the Superintendent or designee shall use these community resources to provide parents/guardians with instruction in parenting skills and child abuse prevention.

Child Abuse Reporting

The Board recognizes that child abuse has severe consequences and that the district has a responsibility to protect students by facilitating the prompt reporting of known and suspected incidents of child abuse. The Superintendent or designee shall establish procedures for the identification and reporting of such incidents in accordance with law.

Employees who are mandated reporters, as defined by law and administrative regulation, are obligated to report all known or suspected incidents of child abuse and neglect. Mandated reporters shall not investigate any suspected incidents but rather shall cooperate with agencies responsible for investigating and prosecuting cases of child abuse and neglect.

The Superintendent or designee shall provide training regarding the reporting duties of mandated reporters.

In the event that training is not provided to mandated reporters, the Superintendent or designee shall report to the California Department of Education the reasons that such training is not provided. (Penal Code [11165.7](#))

Board Policy 3516 Emergencies and Disaster Preparedness

The Board of Education recognizes that all district staff and students must be prepared to respond quickly and responsibly to emergencies, disasters, and threats of disaster.

The Superintendent or designee shall develop and maintain a disaster preparedness plan which details provisions for handling emergencies and disasters and which shall be included in the district's comprehensive school safety plan. (Education Code [32282](#))

The Superintendent or designee shall also develop and maintain emergency plans for each school site.

In developing the district and school emergency plans, the Superintendent or designee shall collaborate with city and county emergency responders, including local public health administrators.

The Superintendent or designee shall use state-approved Standardized Emergency Management System guidelines and the National Incident Command System when updating district and site-level emergency and disaster preparedness plans.

The Board shall grant the use of school buildings, grounds, and equipment to public agencies, including the American Red Cross, for mass care and welfare shelters during disasters or other emergencies affecting the public health and welfare. The Board shall cooperate with such agencies in furnishing and maintaining whatever services they deem necessary to meet the community's needs. (Education Code [32282](#))

Board Policy 5144.1 Suspension and Expulsion/Due Process

The Board of Education has established policies and standards of behavior in order to promote learning and protect the safety and well-being of all students. When these policies and standards are violated, it may be necessary to suspend or expel a student from regular classroom instruction.

Suspended or expelled students shall be denied the privilege of participation in all extracurricular activities during the period of suspension or expulsion.

(cf. [6145](#) - Extracurricular and Cocurricular Activities)

Except where suspension for a first offense is warranted in accordance with law, suspension shall be imposed only when other means of correction fail to bring about proper conduct. (Education Code [48900.5](#))

Expulsion is an action taken by the Board for severe or prolonged breaches of discipline by a student. Except for single acts of a grave nature, expulsion shall be used only when there is a history of misconduct, when other forms of discipline, including suspension, have failed to bring about proper conduct, or when the student's presence causes a continuing danger to self or others.

The grounds for suspension and expulsion and the procedures for considering, recommending and/or implementing suspension and expulsion shall be those specified in law and/or administrative regulation.

Zero Tolerance

The Board supports a zero tolerance approach to serious offenses in accordance with state and federal law. This approach makes the removal of potentially dangerous students from the classroom a top priority and ensures the standardized treatment of all students. Staff shall immediately report to the Superintendent or designee any incidence of offenses specified in law, Board policy, and administrative regulation as cause for suspension or expulsion.

Student Due Process

The Board shall provide for the fair and equitable treatment of students facing suspension and expulsion by affording them their due process rights under the law. The Superintendent or designee shall comply with procedures for notices and appeals as specified in administrative regulation and/or law. (Education Code [48911](#), [48915](#), [48915.5](#))

Supervised Suspension Classroom

The Board recognizes that students who are suspended from school often have no supervision or guidance during the school hours when they are off campus and may fall behind in the coursework. The Board believes that, in many cases, it would be better to manage the student's behavior by keeping the student at school and providing him/her with supervision that is separated from the regular classroom.

The Superintendent or designee shall establish a supervised classroom suspension program which meets the requirements of law for students suspended for any of the reasons enumerated in Education Code [48900](#) and [48900.2](#), who pose no imminent danger or threat at school, and for whom an expulsion action has not been initiated.

The Superintendent or designee shall examine alternatives to off-campus suspension and may establish a suspension program which involves progressive discipline during the school day on campus; use of conferences between staff, parents/guardians and students; detention; student study teams or other assessment-related teams; and/or referral to school support services staff. The use of such alternatives does not preclude off-campus suspensions.

Required Parental Attendance

The Board believes that parental involvement plays an important role in the resolution of classroom behavior problems. The Board expects that teachers will communicate with parents/guardians when behavior problems arise.

Whenever a student is suspended from class by a teacher because he/she committed an obscene act, engaged in habitual profanity or vulgarity, disrupted school activities, or otherwise willfully defied valid staff authority, the teacher of the class from which the student was removed may provide that the student's parent/guardian attend a portion of a school day in the class from which the student was suspended. (Education Code [48900.1](#))

Before requiring parental attendance, the teacher shall make reasonable efforts to have the parent/guardian visit the class voluntarily. The teacher also may inform the parent/guardian about available resources and parent education opportunities. Teachers should reserve the option of required parental attendance for cases in which they have determined that it is the best strategy to promote positive interaction between the student and the parent/guardian and to improve classroom behavior.

The teacher shall apply this policy uniformly to all students within the classroom. This policy shall apply only to a parent/guardian who lives with the student. (Education Code [48900.1](#))

When a teacher requires parental attendance, the principal shall send a written notice to the parent/guardian stating that his/her attendance is pursuant to law. (Education Code [48900.1](#))

The notice shall specify that the attendance may be on either the date the student is scheduled to return to class or within one week thereafter.

A parent/guardian who has received a written notice shall attend class as specified in the notice. After completing the classroom visit and before leaving school premises, the parent/guardian also shall meet with the principal or designee. (Education Code [48900.1](#))

The principal or designee shall contact a parent/guardian who does not respond to the request to attend school. The Board recognizes that parent/guardian compliance with this policy may be delayed, modified, or prevented for reasons such as serious illness/injury/disability, absence from town, or inability to get release time from work.

District regulations and school-site rules for student discipline shall include procedures for implementing parental attendance requirements. Parents/guardians shall be notified of this policy prior to its implementation. (Education Code [48900.1](#))

Decision Not to Enforce Expulsion Order

On a case-by-case basis, the enforcement of an expulsion order may be suspended by the Board pursuant to the requirements of law.

The Board of Education desires to provide orderly campuses that create a positive school environment and are conducive to learning. When students initiate or are involved in a campus disturbance that has the potential to threaten the safety of students or staff, the Superintendent or designee may request law enforcement assistance.

The Superintendent or designee and the principal of each school shall establish a school disturbance response plan that is intended to curb disruptions which may lead to riots, violence, or vandalism at school or at school-sponsored events. In developing each school's plan, the Superintendent or designee shall consult with local law enforcement authorities to create guidelines for law enforcement support and intervention.

The Board of Education desires students and staff to be free from the danger presented by firearms and other weapons.

Possession of Weapons

The Board prohibits any person other than authorized law enforcement or security personnel from possessing weapons, imitation firearms, or dangerous instruments of any kind in school buildings, on school grounds or buses, or at a school-related or school-sponsored activity away from school, or while going to or coming from school.

Students possessing without permission or threatening others with a weapon, dangerous instrument or imitation firearm are subject to suspension and/or expulsion in accordance with law, Board policy and administrative regulations.

Under the power granted to the Board to maintain order and discipline in the schools and to protect the safety of students, staff and the public, any school employee is authorized to confiscate a weapon, dangerous instrument or imitation firearm from any person on school grounds.

To prevent potential misuse that may harm students or staff, students are prohibited from carrying tear gas or tear gas weapons such as pepper spray on campus or at school activities.

The Board encourages students to promptly report the presence of weapons, injurious objects or other suspicious activity to school authorities. The identity of a student who reports such activity shall remain confidential to the extent permitted by law.

Board Policy 5145.3 Nondiscrimination/Harassment

The Board of Education desires to provide a safe school environment that allows all students equal access and opportunities in the district's academic and other educational support programs, services, and activities. The Board prohibits, at any district school or school activity, unlawful discrimination, including discriminatory harassment, intimidation, and bullying of any student based on the student's actual or perceived race, color, ancestry, national origin, nationality, ethnicity, ethnic group identification, age, religion, marital or parental status, physical or mental disability, sex, sexual orientation, gender, gender identity, or gender expression or association with a person or group with one or more of these actual or perceived characteristics.

This policy shall apply to all acts related to school activity or to school attendance occurring within a district school. Any school employee who witnesses an incident of unlawful discrimination, including discriminatory harassment, intimidation, retaliation, or bullying, shall immediately intervene to stop the incident when it is safe to do so. Unlawful discrimination, including discriminatory harassment, intimidation, or bullying, includes physical, verbal, nonverbal, or written conduct based on any of the categories listed above. Unlawful discrimination also shall include the creation of a hostile environment when the prohibited conduct is so severe, persistent, or pervasive that it affects a student's ability to participate in or benefit from an educational program or activity; creates an intimidating, threatening, hostile, or offensive educational environment; has the effect of substantially or unreasonably interfering with a student's academic performance; or otherwise adversely affects a student's educational opportunities.

Unlawful discrimination also includes disparate treatment of students based on one of the categories above with respect to the provision of opportunities to participate in school programs or activities or the provision or receipt of educational benefits or services.

The Board also prohibits any form of retaliation against any individual who files or otherwise participates in the filing or investigation of a complaint or report regarding an incident of discrimination. Retaliation complaints shall be investigated and resolved in the same manner as a discrimination complaint.

The Superintendent or designee shall facilitate students' access to the educational program by publicizing the district's nondiscrimination policy and related complaint procedures to students, parents/guardians, and employees. He/she shall provide training and information on the scope and use of the policy and complaint procedures and take other measures designed to increase

the school community's understanding of the requirements of law related to discrimination. The Superintendent or designee shall regularly review the implementation of the district's nondiscrimination policies and practices and, as necessary, shall take action to remove any identified barrier to student access to or participation in the educational program. He/she shall report his/her findings and recommendations to the Board after each review.

Board Policy 5132 Dress and Grooming

The Board of Education believes that appropriate dress and grooming contribute to a productive learning environment. The Board expects students to give proper attention to personal cleanliness and to wear clothes that are suitable for the school activities in which they participate. Students' clothing must not present a health or safety hazard or a distraction which would interfere with the educational process.

The principal, staff and parents/guardians at a school may establish a reasonable dress code that prohibits students from wearing gang-related apparel when there is evidence of a gang presence that disrupts or threatens to disrupt the school's activities. Uniforms

In order to promote student safety and discourage theft, peer rivalry and/or gang activity, the principal, staff and parents/guardians at a school may establish a reasonable dress code requiring students to wear uniforms. Such a dress code may be included as part of the school safety plan and must be presented to the Board for approval. The Board shall approve the plan upon determining that it is necessary to protect the health and safety of the school's students.

If a school's plan to require uniforms is adopted, the Superintendent or designee shall establish procedures whereby parents/guardians may choose to have their children exempted from the school uniform policy. Students shall not be penalized academically, otherwise discriminated against or denied attendance to school if their parents/guardians so decide. (Education Code [35183](#))

The Superintendent or designee shall ensure that resources are identified to assist economically disadvantaged students in obtaining uniforms.

Board Policy 5131.2 Bullying Prevention

The Board of Education recognizes the harmful effects of bullying on student learning and school attendance and desires to provide safe school environments that protect students from physical and emotional harm. District employees shall establish student safety as a high priority and shall not tolerate bullying of any student.

No individual or group shall, through physical, written, verbal, or other means, harass, sexually harass, threaten, intimidate, retaliate, cyberbully, cause bodily injury to, or commit hate violence against any student or school personnel.

Cyberbullying includes the creation or transmission of harassing communications, direct threats, or other harmful texts, sounds, or images on the Internet, social media, or other technologies using a telephone, computer, or any wireless communication device. Cyberbullying also includes breaking into another person's electronic account and assuming that person's identity in order to damage that person's reputation.

Strategies for addressing bullying in district schools shall be developed with involvement of key stakeholders, including students, parents/guardians, and staff, and may be incorporated into the comprehensive safety plan, the local control and accountability plan, and other applicable district and school plans.

As appropriate, the Superintendent or designee may collaborate with law enforcement, courts, social services, mental health services, other agencies, and community organizations in the development and implementation of joint strategies to promote safety in schools and the community and to provide services for alleged victims and perpetrators of bullying.

Bullying Prevention

To the extent possible, district schools shall focus on the prevention of bullying by establishing clear rules for student conduct and implementing strategies to promote a positive, collaborative school climate. Students shall be informed, through student handbooks and other appropriate means, of district and school rules related to bullying, mechanisms available for reporting incidents or threats, and the consequences for engaging in bullying.

As appropriate, the district shall provide students with instruction, in the classroom or other educational settings, that promotes effective communication and conflict resolution skills, social skills, character/values education, respect for cultural and individual differences, self-esteem development, assertiveness skills, and appropriate online behavior.

Staff shall receive related professional development, including information about early warning signs of harassing/intimidating behaviors and effective response.

Based on an assessment of bullying incidents at school, the Superintendent or designee may increase supervision and security in areas where bullying most often occurs, such as classrooms, playgrounds, hallways, restrooms, and cafeterias.

Intervention

Students are encouraged to notify school staff when they are being bullied or suspect that another student is being victimized. In addition, the Superintendent or designee shall develop means for students to report threats or incidents confidentially and anonymously.

School staff who witness an act of bullying shall immediately intervene to stop the incident when it is safe to do so. (Education Code [234.1](#))

When appropriate based on the severity or pervasiveness of the bullying, the Superintendent or designee shall notify the parents/guardians of victims and perpetrators and may contact law enforcement.

The Superintendent, principal, or principal's designee may refer a victim, witness, perpetrator, or other student affected by an act of bullying to a school counselor, school psychologist, social worker, child welfare attendance personnel, school nurse, or other school support service personnel for case management, counseling, and/or participation in a restorative justice program as appropriate. (Education Code 48900.9)

Complaints and Investigation

Any student, parent/guardian, or other individual who believes that a student has been subjected to bullying or who has witnessed bullying may report the incident to a teacher, the principal, a compliance officer, or any other available school employee. Within one business day of receiving such a report, a staff member shall notify the principal of the report, whether or not a uniform complaint is filed. Within two business days of receiving a report of bullying, the principal shall notify a district compliance officer identified in AR 1312.3. In addition, any school employee who observes an incident of bullying involving a student shall, within one business day, report his/her observation to the principal or a district compliance officer, whether or not the alleged victim files a complaint.

When the circumstances involve cyberbullying, individuals with information about the activity shall be encouraged to save and print any electronic or digital messages that they feel

constitute cyberbullying and to notify a teacher, the principal, or other employee so that the matter may be investigated. When a student uses a social networking site or service to bully or harass another student, the Superintendent or designee may file a request with the networking site or service to suspend the privileges of the student and to have the material removed.

When a report of bullying is submitted, the principal or a district compliance officer shall inform the student or parent/guardian of the right to file a formal written complaint in accordance with AR 1312.3. The student who is the alleged victim of the bullying shall

be given an opportunity to describe the incident, identify witnesses who may have relevant information, and provide other evidence of bullying.

Discipline

Corrective actions for a student who commits an act of bullying of any type may include counseling, behavioral intervention and education, and, if the behavior is severe or pervasive as defined in Education Code [48900](#), may include suspension or expulsion in accordance with district policies and regulations.

Board Policy 1312.3 Uniform Complaint Procedure

The Board of Education recognizes that the district has the primary responsibility to ensure compliance with applicable state and federal laws and regulations governing educational programs. The Board encourages the early, informal resolution of complaints whenever possible and appropriate. To resolve complaints which cannot be resolved through such informal process, the Board shall adopt a uniform system of complaint processes specified in 5 CCR [4600-4670](#) and the accompanying administrative regulation.

The district's uniform complaint procedures (UCP) shall be used to investigate and resolve the following complaints:

1. Any complaint alleging district violation of applicable state or federal law or regulations governing adult education programs, consolidated categorical aid programs, migrant education, career technical and technical education and training programs, child care and development programs, child nutrition programs, and special education programs (5 CCR [4610](#))

Any complaint alleging bullying in district programs and activities, regardless of whether the bullying is based on a person's actual or perceived characteristics of race or ethnicity, color, ancestry, nationality, national origin, ethnic group identification, age, religion, marital or parental status, physical or mental disability, sex, sexual orientation, gender, gender identity, gender expression, or genetic information, or any other characteristic identified in Education Code [200](#) or [220](#), Government Code [11135](#), or Penal Code [422.55](#), or based on his/her association with a person or group with one or more of these actual or perceived characteristics

4. Any complaint alleging district violation of the prohibition against requiring students to pay fees, deposits, or other charges for participation in educational activities (5 CCR [4610](#))

7. Any other complaint as specified in a district policy

The Board recognizes that alternative dispute resolution (ADR) can, depending on the nature of the allegations, offer a process to reach a resolution to the complaint that is agreeable to all parties. One type of ADR is mediation, which shall be offered to resolve complaints that involve more than one student and no adult. However, mediation shall not be offered or used to resolve any complaint involving sexual assault or where there is a reasonable risk that a party to the mediation would feel compelled to participate. The Superintendent or designee shall ensure that the use of ADR is consistent with state and federal laws and regulations.

In filing and investigating complaints, the confidentiality of the parties involved shall be protected as required by law. As appropriate for any complaint alleging retaliation, unlawful discrimination, or bullying, the Superintendent or designee shall keep confidential the identity of the complainant and/or the subject of the complaint, if he/she is different from the complainant, as long as the integrity of the complaint process is maintained.

When an allegation that is not subject to the UCP is included in a UCP complaint, the district shall refer the non-UCP allegation to the appropriate staff or agency and shall resolve the UCP-related allegation(s) through the district's UCP.

The Superintendent or designee shall provide training to district staff to ensure awareness and knowledge of current law and related requirements, including the steps and timelines specified in this policy and the accompanying administrative regulation.

The Superintendent or designee shall maintain records of all UCP complaints and the investigations of those complaints. All such records shall be destroyed in accordance with applicable state law and district policy.

Non-UCP Complaints

The following complaints shall not be subject to the district's UCP but shall be referred to the specified agency: (5 CCR [4611](#))

1. Any complaint alleging child abuse or neglect shall be referred to the County Department of Social Services, the County Protective Services Division, and the appropriate law enforcement agency.
2. Any complaint alleging health and safety violations by a child development program shall, for licensed facilities, be referred to Department of Social Services and shall, for licensing-exempt facilities, be referred to the appropriate Child Development regional administrator.
3. Any complaint alleging employment discrimination shall be sent to the California Department of Fair Employment and Housing and the compliance officer shall notify the complainant by first class mail of the transfer.
4. Any complaint alleging fraud shall be referred to the California Department of Education.

In addition, the district's Williams Uniform Complaint Procedures, AR 1312.4, shall be used to investigate and resolve any complaint related to sufficiency of textbooks or instructional materials, emergency or urgent facilities conditions that pose a threat to the health or safety of students or staff, or teacher vacancies and misassignments. 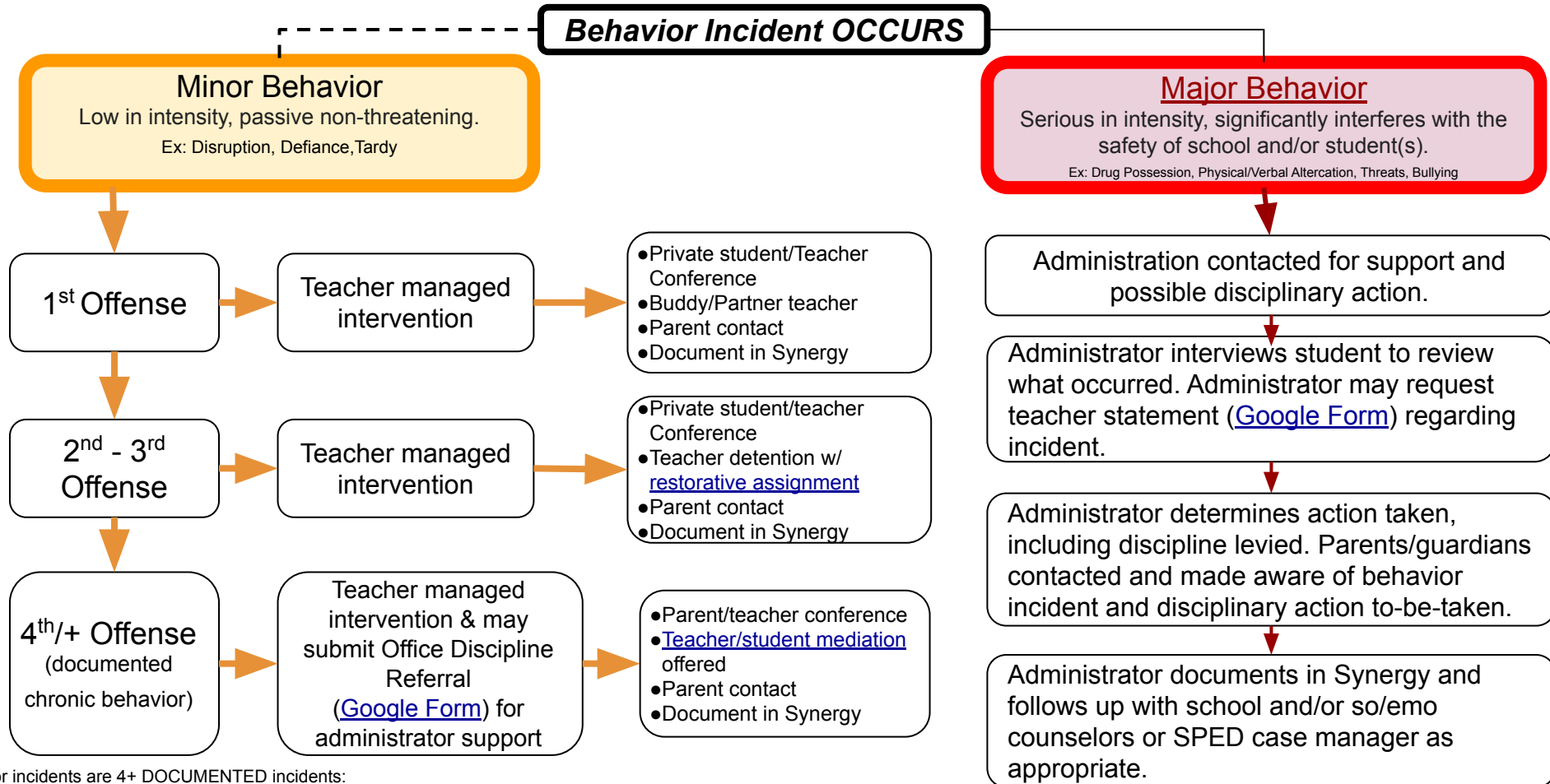

PVHS Behavior Incident Response Flow Chart

Classroom management plans include opportunities for teachable moments and minimizing interruption to instruction. As part of that, teachers teach students their classroom expectations, rules and procedures. This should include reinforcement for meeting these and the consequences for failing to do so.



Chronic minor behavior incidents are 4+ DOCUMENTED incidents:

- All incidents must be for the same behavior
- All incidents must be documented in Synergy
- All incidents cannot take place on the same day/class period
- Three** different intervention strategies must be implemented
